SHIFTING OF 400 kV TRANSMISSION LINE

RAPP Transmission Company Limited

Dear Bidders,

RAPP Transmission Company Limited (RTCL) operates one 400 kV D/C overhead transmission line of approximately 403 ckms in the states of Rajasthan and Madhya Pradesh, RTCL has received request from NHA1 for shifting of the transmission line between tower locations no. 9/10 and 11/0 for development of Green Field Delhi-Mumbai corridor under Bharatmala Pariyojana.

Competent and capable bidders are hereby requested to submit proposal for the line shifting works as per BOQ attached as Schedule I.

The Contract Format is attached as Schedule II.

Technical Specifications are attached Schedule III.

Interested bidders shall fulfil the following Essential Qualifications for award of the line shifting works by RTCL.

- a) The bidder should have Constructed (Including Supply of Materials, Erection, Testing & Commissioning) of a minimum of 500 KM EHV line of 400 kV in the last three years.
Or
Should have been Involved in operation and maintenance of 500 KM 400 kV or above rating transmission lines for last five years
- b) Minimum liquidity (to be calculated as sum of net current assets and cash & bank balances) of Rupees Five Crore, to be certified by a Chartered Accountant. Alternatively, the bidder should submit a line credit of equivalent value from a scheduled /national bank.

In addition to above the Bidder should have the following additional qualification

- c) Bidders should have its Own Tower Manufacturing facility with a minimum capacity of 25000MT per annum and should have supplied not less than 50000MT cumulative in last 3 years.
Alternatively the bidder can submit a letter of support from any of the approved manufacturer as per Annexure (Approved Manufacturers List).
- d) In the event of bidder submitting Letter of Support from approved manufacturer an additional CPBG of 10% of Tower Supply value shall be required to be submitted.

- e) Bidder should have at least ONE no of Tension Stringing Equipment (TSE) set of 8 MT capacity or should demonstrate access to one.

Interested Bidders shall submit proposals as mentioned below:

1. Document in support of Essential Qualifications
2. Document in support of other competencies including company organisation structure and capabilities with profile of key management personnel as well as site operations teams.
3. Signed copy of the Schedule II, Schedule III and Schedule IV evidencing acceptance of all terms and conditions.
