# Subject: - Intimation of Record Date under Regulations 60(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for partial prepayment

Dear Sir/ Madam,

India Grid Trust ("IndiGrid or Issuer") has issued and allotted Series T & V Debt Securities on August 24, 2023. Further, the 'Coupon Reset' clause of both the series reads out as below:

"the Issuer shall, within 2 working days of the issuance of additional units during the tenor of the Debt Securities, notify the Debt Security Holders of such issuance along with revised coupon rate applicable to the Debt Securities, Debt Security Holders will have to convey their acceptance or rejection to Issuer or shall mutually agree on final revised coupon rate within 3 (three) working days of receipt of revised coupon rate from the Issuer. The Issuer shall issue a notice to the Debt Security Trustee and the Debt Security Holders setting out the revised coupon rate agreed within 2 (two) working days of the revised coupon rate being agreed. The revised coupon rate, if agreed, shall be payable on and from the next Coupon Payment Date. If the revised Coupon rate suggested by the Issuer, is unacceptable to the Debt Security Holders and/or no consensus is reached between the Issuer and the Debt Security Holders within 3 (three) working days of receipt of revised coupon rate from the Issuer, then the Issuer shall, mandatorily redeem the Debt Securities at par within 20 working days from expiry of said 3 (three) working days by giving minimum 7 (seven) days' notice to the Debt Security Holder/ Debt Security Trustee. For avoidance of doubt incase additional unit capital raise is less than the outstanding amount under this issue then above reset and redemption shall be applicable only to the extent of additional unit capital raised and redemption will be in proportion to the total debt securities held by debt security holders under both the Series i.e. Series T & Series V."

Accordingly, IndiGrid issued a notice to the Debt Security Trustee and the Debt Security Holders setting out the revised coupon rate within 2 working days of the issuance of additional units and the same is unacceptable by the Debt Security Holders and no consensus is reached between the Issuer and the Debt Security Holders. Therefore, IndiGrid will redeem the debt securities to the extent of units issued as mentioned in the below table:
