Pursuant to Regulation 23 of Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014 read with all the Schedules and Circulars, as amended from time to time, this is to inform you that the Issue Committee of IndiGrid Investment Managers Limited (the "Issue Committee"), acting in the capacity of investment manager of IndiGrid, has, at its meeting held today, December 8, 2023, pursuant to the Issue, approved the issue and allotment of 5,26,93,338 Units to institutional investors at the issue price of ₹ 127 per Unit (which included a discount of ₹2.55 (i.e. ~1.97%) on the floor price of ₹129.55 per Unit)], aggregating to ₹ 6,69,20,53,926 (Rupees Six Hundred Sixty Nine Crores Twenty Lakhs Fifty Three Thousand Nine Hundred and Twenty Six only).

The Issue opened on December 5, 2023, and closed on December 8, 2023
