Pursuant to the applicable provisions of the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014, as amended from time to time, read with circulars and guidelines issued thereunder (“**SEBI InvIT Regulations**”), applicable provisions of the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements), 2015 as amended from time to time read with circulars and guidelines issued thereunder (“**LODR Regulations**”), we hereby inform that the Scheme of Amalgamation between Universal Saur Urja Private Limited, Terralight Solar Energy Tinwari Private Limited, Terralight Solar Energy Patlasi Private, the Special Purpose Vehicles of IndiGrid Infrastructure Limited (“IndiGrid”) and IndiGrid Limited, the HoldCo of IndiGrid, has been withdrawn pursuant to the order passed by the Hon’ble National Company Law Tribunal, New Delhi and the certified copy of which was received on July 01, 2026. Accordingly, the Scheme of Amalgamation shall stand revoked, cancelled be of no effect.
